# CALL TO ORDER:

The meeting was called to order at 5:45 p.m. by Board Chair Ryan Wade.

## AGENDA:

Bambi moved to approve the agenda and Ryan seconded the motion. Board voted all in favor.

## **MINUTES:**

Bambi moved to approve the November regular and December 2<sup>nd</sup> special school board meeting minutes. Ryan seconded and the Board voted all in favor.

## **PUBLIC COMMENT:**

## **CLERK'S REPORT/WARRANT APPROVAL:**

Ann reported that our ESSER I funds have been spent in full and we are now using our ESSER II money (\$10,000) to fund our teacher's aide position. Our current Statement of Expenditure – Budget vs. Actual Report shows we are on budget and have spent 43% of our general fund budget (\$91,224.49)

# TEACHER'S REPORT:

Richelle briefed the Board on updates including:

- Christmas break is December 18 January 3.
- January 17 will be a make-up day due to the school's closure as a result of a power outage on November 16.
- Christmas Program will be Friday, Dec. 17. Program will begin at 6 p.m. followed by a potluck dinner.
- The December and January school calendars were distributed.

## **OLD BUSINESS:**

**Consideration of District's Safe Return to School and Continuity Plan:** Trustees reviewed the school's current plan. There was no public comment. Bambi moved to approve the current plan and Ryan seconded. The Board voted all in favor.

#### **NEW BUSINESS:**

**Tuition Fund 113:** Trustees approved the first reading of a resolution allowing the balance transfer of the District's Tuition Fund totaling \$43.70 to its Building Reserve Fund. Ryan made the motion and Bambi seconded. The Board voted all in favor.

## MAINTENANCE & SAFETY:

Ryan reported that water pressure from the well is extremely low. Champion Water Well Service came out Thursday and said the well pump is dying. They suggested installing a submersible pump. They will send a quote and can do the job during Christmas break.
