School Board Business Meeting Minutes

Tuesday, March 9, 2021

CALL TO ORDER:

The meeting was called to order at 5:45 p.m. by Board Chair Ryan Wade.

ATTENDANCE:

Ryan Wade, board chair; Bambi Wilson, vice chair; Carolyn McIsaac, trustee; Jack Eggensperger, Flathead County Superintendent of Schools; Richelle Sheets, lead teacher; and Ann Marie Becker, district clerk/business mgr. Eggensperger attended via telephone conference.

AGENDA:

Ryan moved to approve the agenda and Carolyn seconded the motion. The Board voted all in favor.

MINUTES:

Ryan moved to approve the February minutes; Bambi seconded. The Board voted all in favor.

PUBLIC COMMENT:

No public comment.

CLERK'S REPORT/WARRANT APPROVAL:

Ryan moved to approve the March 2021 warrant report. Carolyn seconded the motion and the Board voted all in favor. The FY 2021-2022 Preliminary Data Budget Sheets from OPI show PVS' general fund budget as \$91,187.01 (highest budget without a vote)

TEACHER'S REPORT:

- Richelle presented the March Teacher's Report and distributed the monthly newsletter, calendar, Kindergarten Round-Up flyer and test plans.
- School events for March were discussed, including Kindergarten Spring Round Up on March 29th from 9 a.m. to 6 p.m.
- This year, all students in grades 4-6 will take the state's Smarter Balanced Test for math and English language arts.

OLD BUSINESS:

Trustee Election Update: PVS has one trustee position subject to election on May 4th. We have received one filing from Carolyn McIsaac.

School Test Plans: Trustees considered the proposed test plans. Ryan moved to approve the plans and Bambi seconded the motion. The Board voted all in favor.

NEW BUSINESS:

Policy Revue: Ryan made a motion, seconded by Carolyn, to maintain current 1900 series policies, including the school's mask mandate. Jack suggested the Board revisit addressing updates following spring break.

Isolated School Classification Application: Trustees considered applying for isolation status. Due to increased enrollment, Jack favored the consideration. Ryan made a motion that PVS submit the application and Carolyn seconded the motion. The Board voted all in favor.

MTSBA Membership Renewal: Ryan made a motion, seconded by Bambi, to renew PVS' Trustee membership of \$392.00 for the term 7/1/2021 - 6/30/2022.

No items discussed.
